

On March 31, 2014, the President of the United States signed the SGR ("Doc Fix") bill into law. That law officially postponed the implementation of ICD-10 until at least Oct. 1, 2015. Based on the new implementation date, CPSI has updated our ICD-10 timeline. The information below is an estimate as to when specific programming is expected to be complete. Please note that it is possible the estimates contained in this document may change due to unforeseen circumstances or future regulation changes. As programming changes are completed, they will be made available to CPSI customers on upcoming software updates.
