Evident ICD-10 Updates



Ad Hoc Reporting:

To accommodate the ICD-10 code sets, Evident has created a new file to store the ICD-10 codes. Additionally, in order to meet Meaningful Use, a new file was created to store the patient's physicians. As a result of our prior transition to an SQL-compliant database structure, all new files in Evident are created only within the SQL-compliant Postgres database. As the Ad Hoc reporting application only reads COBOL files, ICD-10 code information and information stored in the new physician file will not be available through traditional methods within the application.

Alternatively, Evident is creating new reporting options for ICD-10 code information and physician information. New reports are currently available in the "Ad Hoc" option under "Report Dashboard". Please note that HIM reports in this area that are specific to ICD-10 codes will only pull data for accounts that have been coded in ICD-10. For these reports, if the patient account was only coded in ICD-9, the account will not pull to the report. Reports that are currently in development will also be added to this area.

Thrive Provider EHR:

As the implementation of ICD-10 approaches, we want to inform you of changes coming to the Thrive Provider EHR electronic superbill. Currently, within the electronic superbill there is a section dedicated to storing diagnosis codes that have been loaded in the MP-EHR Menu in the Business Office Tables option. In order to accommodate the ICD-10 code set within the superbill, we will be removing the hardcoded diagnosis section as well as the ability to manually add an ICD-9 code to an "other" box.

Evident ICD-10 Updates



Going forward, ICD-10 codes will be populated to the superbill as an automatic update from the codes being added to the Physician Problem List. The addition of diagnosis codes to the Physician Problem List is required to meet Meaningful Use and is considered best practice within Thrive Provider EHR as it provides more detailed and comprehensive coding and documentation. As long as a diagnosis is added to the Problem List and the "addressed" date matches the date of service, then it will pull to the electronic superbill. After the provider reviews and posts the entries, they can be viewed in Transaction Entry.

The above software change is complete and contained on the 1919.19 Thrive software update. It is vital that all clinics and their providers utilizing the Thrive Provider EHR software be informed of this change as it significantly impacts provider and administrative workflow.

ICD-10 Preparation:

With the ICD-10 compliance date less than four months away, all facilities' Health Information Management departments should now be familiar with using the new Grouper screen. Failure to test or implement the new Grouper screen prior to the compliance date will have a significant impact on coder productivity. Access to the new Grouper screen is controlled by Rule Based Security. If additional assistance is needed, please contact an Evident HIM Support Representative.

Clinical Vocabulary:

As a reminder, Clinical Vocabulary is required to accommodate ICD-10. Any facility that has not purchased this application should immediately contact their Evident Account Manager.
