ICD-10-Readiness Assessment-What?

 Tool to enable an organization to be proactive in initiating the necessary steps to gather information needed to prepare for ICD-10






- ICD-10-CM and PCS coding structure will limit one-to-one code matching
- Changes will need to be made to support the coding format
- Organizations will need to address challenges throughout
 - Consider consultants to assist with the process



- Physician champion named
- Processes currently affected by ICD-9 are identified
- Current workflow identified



- In this call, the following are established:
 - Days on site (To and From)
 - Number of days on site and hours
 - Date and time of Kick-off meeting and key staff to be involved
 - Key individuals who will participate in the assessment and department represented
 - Agenda created

- Meeting space and menu planning
- Meeting logistics
- A/V needs
- Timeline for staff meetings and Overview of ICD-10 education





- On site Kick-off meeting with key staff
- Senior Administration
 - o CEO
 - CFO
 - o IT
- Physician Champion
- Clinical administration
- HIM Director
- Business Office Mgr.
- Patient Registration and Admitting





- Project Plan is reviewed
- Kick-off presentation made about ICD-10
- Expectations set and agreed
- Meeting schedule reviewed and changes made if needed
- Educational opportunity for physician champion discussed and meeting set
- Tour of facility and operations
- Introductions of individuals involved in department assessments made



On Site Department Meetings

- Meetings are held with department heads to discuss day to day operations of department
- Introduction of staff in the department
- Education level and knowledge of ICD-9 and ICD-10 discussed
- Processes involving ICD-9 that will be impacted by ICD-10 are identified



- Formatted assessment is completed by the consultant with the cooperation of the department head
- Tour of department is performed and shadow with personnel who are involved in ICD-9 processes
- Information is captured about current processes along with any suggestions



- In the Nursing Administration meetings (QA, CM, etc.)
 - Discussion about current documentation challenges
 - Documentation tools needed
 - Documentation challenges are identified and examples discussed



- Effects of documentation on reimbursement and DRGs is discussed
- Knowledge of ICD-10 is discussed
- Questions about myths and expectations of ICD-10 are addressed





- Meetings with IT are to determine:
 - Facility readiness with hardware



- Current reporting format and reports currently in use that include ICD-9 codes and will include ICD-10
- Dedicated server available for testing
- Storage of historical data with both ICD-9 and ICD-10 codes
- Updating of Policies and Procedures in anticipation of ICD-10 transition
- Payer education opportunities for testing and education



On-site Meeting with Physician "Champion"

- Establish important to gain physician "buy in" to ICD-10 and documentation needs
- Present ICD-10 overview
- Discuss current documentation and coding challenges
- Queries and turnaround time responses
- Ease of using EHR and EMR



On-site Meeting with Physician "Champion" (cont.)

- Recognition of Electronic Health and Medical Records as tools
- Discuss physician resources physicians who may have already had ICD-10 training to assist with transition and education of others





Education with Billers, Coders and Bus. Office Staff

- Presentation made of Overview of ICD-10
- Presentation made of ICD-CM and PCS with examples
- Presentations include Continuing Education Credit (CEs)
- Assessment completed with Bus. Office Mgrs., HIM Dir. about educational needs



Education with Billers, Coders and Bus. Office Staff (cont.)

- Vendor sought for education
- Timeline for education
- Credentials of coders, billers and organizational affiliation identified
- Educational opportunities for staff above ICD-10 (Anatomy, Medical Terminology)





ICD-10 Education for Nurses

- ICD-10 Overview presented
- Continuing Education (CE) credits awarded to nurses
- Education for nurses and physicians for ICD-10 discussed and vendor possibilities
- Documentation tools for nurses discussed
- Initiatives to improve physician documentation discussed



ICD-10 Education for Nurses (cont.)

- Relevance of linking pre-existing conditions and impact on DRGs
- Discussion of hospital acquired infections and changes in diagnoses in ICD-10 to capture information (e.g., decubitus ulcers and staging at admission, MRSA, TB (initial encounter, v. sequelae)



Assessment Impact on Policies and Procedures

- Evaluate current Polices & Procedures to ensure support of ICD-10
- Evaluate current department processes that will be impacted by ICD-10
- Create a plan to identify deficiencies
- Create a plan to resolve affect on productivity
- Communicate information to areas affected by ICD-10



Organizational Assessment Measures

- Develop an internal implementation timeline
- Specify resources required to complete identified tasks
- Delineate transition tasks, deadlines, and responsible individuals
- Assess organizational readiness for transition
- Identify systems, applications and databases affected by ICD-10
- Conduct surveys of all business areas to determine level of impact



- Key staff from "Kick-off" meeting present
- Preliminary findings are discussed
- Expectation of delivery of assessment discussed and timeframe agreed
- Suggestions made about improvements of current processes



- Resources identified (staff)
- Current tools available to assist coders in getting acquainted with ICD-10 (utilize encoder tools and testing modules)
- Timelines to educate discussed






- Discussion about current A/R days and anticipated delays resulting in ICD-10 transition and how to prepare
